TAX LEVY ORDINANCE ORDINANCE NO. 1-18

An ordinance of the borough of Prompton, County of Wayne, Commonwealth of Pennsylvania, fixing the tax rate for the year 2018.

Be it ordained and enacted, and is hereby ordained and enacted by the Borough Council of the Borough of Prompton, County of Wayne, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property and occupations within the Borough of Prompton subject to taxation for the fiscal year of 2018 as follows:

For real estate purposes, the sum of 0.9 mills.

For per capita purposes, the sum of 5 dollars.

For real estate transfer purposes, the sum of 0.5 percent.

That any ordinance, or part of ordinance, conflicting with this ordinance be and the same is hereby repealed insofar as the same affects this ordinance.
